# 3. Services Insured

**Freight forwarding** trading under terms of general conditions of Latvian Association of Freight Forwarders (LAFF) accepting <u>liability only in accordance to §2B of LAFF 2007</u>.

## 4. Trading Area

Europe, but excluding CIS countries and official war areas.

Transports of all goods within, to or from the Russian Federation, Belarus, Donetsk, Luhansk, Crimean territory and the Russian Federation's territorial waters are excluded.

If it is unclear where the loss occurred or what the origin or destination of the goods is, and the insurer alleges that, by reason of this exclusion, the loss is not covered by this insurance, the burden of proof of the contrary shall be upon the Insured.

Nothing in this clause limits the applicability and effect of the Sanction Clause in this policy.

Unless specifically agreed, transports or any damage or claim for compensation regarding transport of goods to, from and within Kazakhstan, Turkmenistan, Kyrgyzstan, Uzbekistan, Tajikistan, and Azerbaijan territory are excluded.

## 5. Limit of Liability

EUR 70 000.00 any one accident or occurrence and in all during period of this insurance.

## 6. Terms and Conditions of Insurance

## 6.1. Insuring Clauses

#### 6.2. Claims Co-operation Clause

In the event of an occurrence giving rise or appearing likely to give rise to a claim hereunder immediate notice shall be given to Insurance Company, who shall have a right at their own expense to appoint assessors and/or representatives to

act in conjunction with the Insured and their representatives. It is further noted and agreed by both parties that in case such notice is not given Insurance Company will have a right to decline or restrict a claim hereunder.

#### 6.3. Clause of losses and damages related to illegal border crossers

The Insurance Company sets a liability limit EUR 20 000 (twenty thousand euro) for losses or damages to Third party's cargo during its carriage caused by illegal border crossers, asylum seekers, refugees or persons who have been granted alternative status. Above mentioned liability limit is not applicable to Insured events related to total of partly theft of the cargo.

## 8. <u>Deductible</u>

Deductible – The deductible is the share of the loss specified in the Insurance Contract to be covered by the Policyholder themselves in the event of a loss. The Insurance Company compensates that part of the loss to be covered according to the Contract which exceeds the deductible if not otherwise stated in the Policy Document.

**EUR 750.00** for each Insured event but increased to **EUR 1 000.00** for Insured event in respect of carriage of alcohol, electrical goods and household appliances.
